OFFICIAL RULES**

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. INTERNET ACCESS REQUIRED. DATA RATES MAY APPLY IF ENTERING VIA A MOBILE DEVICE.

1. SWEEPSTAKES PERIOD: The Sweepstakes begins on November 1, 2021 at 12:00:00 p.m. Pacific Time (“PT”) and ends on December 31, 2021 at 11:59:59 p.m. PT (“Sweepstakes Period”). The computer of the Administrator (defined in Section 3) is the official time-keeping device of the Sweepstakes.

2. HOW TO ENTER: During the Sweepstakes Period, visit BigGameLA.com (“Website”) and follow the online instructions to register and submit the entry form to receive one (1) entry into the random drawing. See Section 4 for drawing details.

Limit one (1) entry per person/email address per day. A “day” is defined as the twenty-four (24) hours between 12:00:00 a.m. PT and 11:59:59 p.m. PT of the same day with the exception of the first day of the Sweepstakes which shall begin at 12:00:00 p.m. PT.

Entrants may also access the Website by scanning the code found on displays advertising the Sweepstakes. An entrant cannot participate solely by scanning the code. Entrants must have a smart phone or other web-enabled device with a camera feature or code reader application and may incur data charges from their wireless service provider for each use of the code, depending on their service plan. Entrants are solely responsible for any such wireless charges associated with such use, including the downloading (if applicable) and use of the code reader. If you do not have a code scanner on your phone, search for one in your mobile device’s application store to find available code readers for your phone or device. Code readers may not be available on all devices. Check with your wireless service provider for details on these and any other applicable charges. Mobile entry is not required to submit an entry or win a prize in this Sweepstakes.

All entrants must have a valid email address. The name of the person submitting the entry into the Sweepstakes must be the authorized account holder of the email address used to enter, otherwise, entry may be deemed void. Multiple entrants may not share the same email address. In the event of a dispute over the identity of an entrant, entry will be declared made by the authorized account holder of the email address used during the submission process. A potential winner may be required to provide identification sufficient to show that they are the authorized account holder of such account.

3. ELIGIBILITY: Open only to legal U.S. residents residing in one of the thirty-eight (38) eligible United States (excludes Alaska, Idaho, Maine, North Dakota, New Hampshire, Rhode Island, South Dakota, Utah, Vermont, Washington, West Virginia, Wyoming and the District of Columbia) who are eighteen (18) years of age or older (19 or older if a resident of Alabama or Nebraska) at the time of entry. The following persons are not eligible to participate or win: Employees, contractors, directors and officers

Entries submitted during the Sweepstakes Period are only eligible for this Sweepstakes and do not remain eligible for any subsequent sweepstakes.

5. PRIZE DETAILS: One (1) prize will be awarded, consisting of a trip for winner and winner’s one (1) guest to Super Bowl LVI scheduled to take place on February 13, 2022 in Inglewood, California. Travel dates: February 10, 2022 – February 14, 2022. The trip consists of two (2) Super Bowl LVI tickets; round-trip coach air transportation for winner and one (1) guest from a major airport nearest winner’s home to California; double-occupancy, standard hotel accommodations for four (4) nights; Super Bowl party (as determined by Sponsor, in Sponsor’s sole discretion); shared-bus transportation from hotel to Super Bowl LIV and back to hotel after the game; two (2) commemorative gift bags; and \$750.00 (awarded in the form of a check, payable to winner). Approximate Retail Value (“ARV”): \$13,850.00, depending on winner’s point of departure and destination airport.

Prize General Terms: Ground transportation (other than as stated above), upgrades, meals, gratuities, luggage fees, and all other expenses not specified herein are solely the winner’s responsibility. A minor child may accompany winner as a guest only if minor’s parent or legal guardian is the winner. Minor must be accompanied at all times during the game by minor’s parent or legal guardian. The guest (or his/her parent or legal guardian if guest is a minor) must complete and return a Liability/Travel Release prior to Sponsor’s designated travel agency making travel arrangements. LIMITATIONS OF LIABILITY: Sponsor and Promotion Parties, and the NFL Entities assume no responsibility or liability for (a) any incorrect or inaccurate entry information submitted by entrant, or for any faulty or failed electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes; (d) inaccessibility or unavailability of any network or wireless service or the Website; (e) suspended or discontinued Internet or wireless service; or (f) any injury or damage to entrants or to any person's computer or web-enabled device or property which may be related to or resulting from any attempt to participate in the Sweepstakes or download of any materials in the Sweepstakes. Sponsor reserves the right to correct errors in promotional materials.

WINNER NOTIFICATION: The potential winner will be notified by email and will be required to follow instructions within the notification within forty-eight (48) hours (beginning at the time the notification was sent), or prize may be forfeited, in Sponsor's sole discretion. Additionally, the winner will be required to complete, sign and return an Affidavit of Eligibility/Liability Release ("Affidavit") with (where lawful) a publicity release within seventy-two (72) hours as indicated by the date on the Affidavit. Failure to return the Affidavit within the specified time period may result in prize forfeiture. Sponsor and Promotion Parties are not responsible for suspended or discontinued Internet or wireless service or a change in winner's email address, which may result in a potential winner not receiving prize notification.
